



PUBLIC LICENSE AGREEMENT

regarding the procedure for publishing authors' articles in the journal Economics of Development

1. General Principles and Reference to the Current Edition

1.1. This document is a public offer by the Publisher to enter into an agreement (hereinafter referred to as the “Agreement”) for the publication of authors' materials in the journal Economics of Development.

1.3. This offer is addressed to an indefinite number of persons and is made in accordance with Article 633 of the Civil Code of Ukraine.

2. Definitions and Roles of the Parties

2.1. Author — a natural person (or other rightful owner) who created the material and submits it to the editorial office.

2.2. Publisher — the editorial team/publishing unit of the journal Economics of Development.

2.3. For the purposes of this Agreement, the Author acts as the Licensor, and the Publisher acts as the Licensee.

3. Legal Basis and Procedure for Accession (Acceptance)

3.1. The publication of this Agreement on the journal's official website constitutes an offer of accession.

3.2. Acceptance is considered to occur when the Author fully and unconditionally agrees to the terms of the Agreement (Article 642 of the Civil Code of Ukraine), after prior agreement of the article's content with the editorial office.

3.3. The fact of acceptance is confirmed by the Author sending materials for publication in the Licensee's editions.

4. Scope of Rights Granted and Licensing Terms

4.1. The Author retains copyright to their work and grants the Publisher a non-exclusive Creative Commons Attribution License International (CC-BY) (right of first publication).

4.2. Within the framework of this license, the Licensee has the right to:

4.2.1. Publish articles in English and distribute printed versions.

4.2.2. Translate articles into English (for materials submitted in Ukrainian) and distribute the printed version of the translation.

4.2.3. Distribute electronic versions of articles, as well as the electronic versions of English translations (for materials submitted in Ukrainian) through any electronic means, including publishing them on the official journal website, in electronic databases, repositories, etc.

5. Confirmation of Rights Allocation

5.1. The publication of the author's material in the journal Economics of Development serves as confirmation of the exercise of the granted rights and affirms the distinction of rights between the Licensor and the Licensee.

6. Liability of the Parties

6.1. In the event of non-performance or improper performance of obligations under this Agreement, the Parties shall bear liability in accordance with the current legislation of Ukraine.

7. Dispute Resolution

7.1. Any disputes or disagreements arising under this Agreement shall first be resolved through negotiations between the Parties.

7.2. If an agreement is not reached, the dispute shall be subject to resolution in court in accordance with the legislation of Ukraine.

8. Final Provisions

8.1. In performing this Agreement, the Parties shall be guided by the laws of Ukraine for any matters not directly regulated by its terms.

8.2. Any amendments to this public offer shall take effect from the moment they are published at the address specified in clause 1.2.
