



PUBLIC SERVICE AGREEMENT (PUBLIC OFFER)
for the provision of prepress services

1. Statement of Public Offer

1.1. This document constitutes a public offer by the Contractor to conclude an agreement for the provision of services (hereinafter referred to as the “Agreement”) under the terms set out below.

1.2. Acceptance of this offer by any natural or legal person signifies the acquisition of the status of the Customer and the conclusion of this Agreement in accordance with Article 638 of the Civil Code of Ukraine.

2. Terms and Scope

2.1. The Services include text editing, prepress preparation, electronic layout, publication of materials on the journal’s website, and their archiving.

2.2. The subject of this Agreement is the provision of the above Services by the Contractor to the Customer within the scope and procedure established herein.

2.3. The provision of Services begins only after the receipt of all positive peer reviews confirming the article’s eligibility for publication.

3. Acceptance and Commencement of Cooperation

3.1. The Agreement shall be deemed concluded at the moment the Customer first sends scientific and/or other texts to the official editorial e-mail address.

3.2. Acceptance constitutes the Customer’s full and unconditional consent to the terms of this Agreement and the Privacy Policy, as well as their obligation to comply with them.

4. Composition and Procedure for the Provision of Services

4.1. The editorial board accepts manuscripts intended for publication in the print medium for processing free of charge.

4.2. The Customer undertakes to:

- a) send the manuscript to the official e-mail address of the editorial office;
- b) provide, upon request, information and perform actions that the editorial board considers necessary and sufficient for fulfilling the order.

5. Timeframe and Completion of Work

5.1. The standard period for the provision of Services is up to four (4) months from the date of acceptance.

5.2. In exceptional cases, the period may be agreed upon individually between the Contractor and the Customer.

5.3. The Services shall be considered rendered, and the obligations fulfilled, once the final publication layout has been approved by the Editor-in-Chief for the issue containing the Customer’s material.

6. Cost and Confirmation of Acceptance

6.1. The Services under this Agreement are provided free of charge.

6.2. The fact of acceptance and the conclusion of this Agreement is confirmed by the first submission of materials by the Customer (see clause 3.1).

7. Validity and Amendment of the Offer

7.1. This Offer takes effect from the moment it is published online at the address specified in clause 1.3 and remains valid until withdrawn by the Contractor.

7.2. The Agreement enters into force upon acceptance and remains effective until all obligations of the Parties are fully discharged.

7.3. The Parties may terminate this Agreement early by mutual consent.

7.4. This Offer is not irrevocable; the editorial office reserves the right to refuse the provision of services to persons who do not agree with its terms.

8. Personal Data

8.1. By entering into this Agreement, the Parties grant each other the right and consent for the indefinite processing of personal data in accordance with the Law of Ukraine “On Personal Data Protection”.

8.2. The use and dissemination of personal data shall be carried out solely to the extent necessary to ensure the operation and/or protect the interests of the Parties and to fulfil the provisions of this Agreement.

9. Liability

9.1. For non-performance or improper performance of their obligations under this Agreement, the Parties shall bear liability in accordance with the applicable legislation of Ukraine.

10. Dispute Resolution

10.1. Any disputes or disagreements shall be resolved through negotiations between the Parties.

10.2. If no agreement is reached, the dispute shall be settled in court in accordance with the legislation of Ukraine.
